**Age category**: students 18 years and over (gymnasts born -99 or earlier) Exception for age limits: Maximum two (2) members of the group may be one (1) year younger than the given minimum age.

All gymnasts must be students of the same University. EUSA Cup Open competition runs with IFAGG rules and regulations.

Accommodation must be booked through the organizers. Accommodation shall be paid as per the invoice issued by the organizer. Please, take care to pay the accommodation invoice within the due date to confirm the offered accommodation conditions. The number of rooms is limited.

Participants are able to purchase a tranposrtation from the Helsinki-Vantaa airport/harbour to the hotel. Round trip price is 25€/person.

Participants are able to purchase a meal-package (6 meals from Thursday dinner to Sunday lunch). Meals will be served in the Official Hotel Scandic Park. Meal-package will cost 50€/ person.

There will be possibility to purchase meals individually on Wednesday (lunch, dinner), Thursday (lunch) and Monday (lunch, dinner). Price for the lunch is 10 €/meal and dinner 12€/meal.

#### Important:

# The hotel rooms and lunches must be definitively reserved before 15<sup>th</sup> of March 2017. After that you may change the order by maximum 20% of the total order without extra cost.

The Local Organizing Committee does not cover costs of delegation.

The organizing club sends an invoice (Start fee, ordered transportation, ordered meals and accommodation). All the costs of participation have to be payed via bank transfer to the OC bank account before the 30<sup>th</sup> of April 2017.
