Delegations will be responsible for all their judges expenses (visa and travel, accommodation).

<b>INSURANCE</b>	<p>The Federation of Aesthetic Group Gymnastics of Kyrgyz Republic and IFAGG will not be responsible for any liabilities in case of accidents, illness, repatriation and such as.</p> <p>The IFAGG Technical Regulations foresee that all participating delegations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all members of their Delegation.</p> <p>The FAGG KR will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy).</p>
<b>MEDICAL SERVICES</b>	<p>The Local Organizing Committee will provide a first medical aid service, an emergency medical transportation to the nearest clinics <b>ONLY</b> from the training area.</p> <p>If there are will be any restrictions over entrance in Kyrgyz Republic, LOC will make an announcement to all participants</p>

<b>ANTIDOPING</b>	<p>IFAGG Code of Discipline</p> <p>It's a condition of participation in IFAGG's activities that gymnasts and their assistants and representatives will follow the national and international doping rules. All gymnasts and their assistants and representatives are obligated to know the doping rules. <b>PERSONAL DATA PROTECTION</b>	<p>Personal information of registered gymnasts, coaches, judges and volunteers are used in published official competition protocols, rgform.eu online environment, competition's/federation's website and in social media channels. By registering to the event, the gymnasts, coaches, judges and volunteers are giving a consent to publish visual materials (photos, videos) on which they might be displayed. In case the person is not consent with the previous, LOC and federation has to be informed in written form by the start of the competition. Only photographers and journalists with accreditation are allowed to take pictures and film the event.</p>
<b>ACCREDITATION</b>	<p>Accreditation will take place upon arrival of the teams to "SOLEMAR" venue in Cholpon-Ata, Kurumdu village</p> <p><b>During the accreditation Head of Delegations must:</b></p> <ul style="list-style-type: none"> <li>• check and make corrections (if any) in names of all delegation members;</li> <li>• provide passports of all gymnasts for age and nationality inspection;</li> <li>• proof of medical insurance of all delegation members;</li> <li>• check music files;</li> <li>• fill out personal data protection declaration;</li> <li>• make any necessary payments;</li> <li>• provide background form</li> </ul>
<b>VISA INVITATION</b>	<p>All delegation members requiring a Visa or Invitation to enter Kyrgyz Republic must send visa request FORM to LOC (form will be attached in KSIS) <a href="mailto:fag.kyrgyzrepublic@gmail.com">fag.kyrgyzrepublic@gmail.com</a>.</p> <p>Kyrgyzstan Entry Visa obtaining process takes usually from 5 to 7 working days and can be done through the E-visa platform of MFA of Kyrgyz Republic <a href="http://evisa.e-gov.kg">evisa.e-gov.kg</a>.</p> <p><b>Deadline: May 10<sup>th</sup>, 2023</b></p>
<b>ACCOMMODATION</b>	<p>All KGZ non-resident participants are obliged to stay in the official hotel.</p> <p>All accommodation options information will be provided no later than April 8th, 2023 on KSIS platform</p>


