The LOC will verify the insurance upon arrival of the delegation members (e.g., cover note or photocopy of the valid policy).</p>
MEDICAL SERVICES	<p>The Local Organizing Committee will provide a first aid medical service, a doctor and emergency medical transportation in the competition area.</p>
ANTIDOPING	<p>IFAGG Code of Discipline.</p> <p>It's a condition of participation in IFAGG's activities that gymnasts and their assistants and representatives follow the national and international doping rules. All gymnasts and their assistants and representatives are obligated to know the doping rules. PERSONAL DATA PROTECTION	<p>Personal information of registered gymnasts, coaches, judges and volunteers are used in published official competition protocols, rgform.eu online environment, competition's/federation's websites and on social media channels. By registering to the event, the gymnasts, coaches, judges and volunteers are giving consent to publish visual materials (photos, videos) on which they might be displayed. In case the person does not consent with the aforementioned, the LOC and federation has to be informed in writing by the start of the competition. Only photographers and journalists with accreditations are allowed to take pictures and film the event.</p>
ACCREDITATION	<p>The Delegation will be accredited upon their arrival During the accreditation Heads of Delegations are required to:</p> <ul style="list-style-type: none"> • check the correct spelling of the names fo their entire delegation; • do a passport control of all gymnasts • show proof of medical insurance of all delegation members • do a music check • submit personal data protection declaration • make any necessary payments
VISA	<p>All delegations requiring a visa must complete the visa request form and send it to the LOC (form can be found on the KSIS platform).The</p>

INVITATION	request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the delegation member, as well as the city the visa application support letter must be sent to. Deadline: January 22, 2026
